# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to 1100 Main St and Dyal Custom Homes and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Dyal Custom Homes include 1100 Main St. The Dyal Custom Homes website is a business representation site. ### **Collection of your Personal Information**
